INZ Skilled Immigrant Authorization Letter - Application under H1B Work Visa

Thank you for your application for leave to remain in New Zealand under Work Visa within the Immigration New Zealand Rules for Three Years filed in by your employers (Apex Mega Centre), we wish to officially inform you that your application has been granted and as such we are issuing you with this INZ Skilled Immigrant Authorization Letter as a proof that you can go ahead and apply for Work Visa after completing your Skilled Migrant Certification.

[OPTION 1: CONDITIONS - NO RECOURSE TO PUBLIC FUNDS ONLY]

Please note that the endorsement includes the condition that you do not have recourse to public funds.

[OPTION 2: CONDITIONS – NO RECOURSE TO PUBLIC FUNDS AND WORK IN YOUR AREA OF SPECIALIZATION ACCEPTED]

Please note that the endorsement includes the following conditions:

- You do not have recourse to public funds; and,
- You are not allowed to undertake employment outside your area of specialization as we are fully aware of your capabilities which also meet our standards.

[OPTION 3: REQUIREMENTS FOR WORK VISA | SKILLED MIGRANTS GENERAL CATEGORY]

You must immediately register with the Ministry of Business, Innovation and Employment to complete your Skilled Migrant Certification before we can issue out your Work Visa i.e. Residence and Work Permit / Visa / Family Resident Permit that also covers for your family dependents. You must register within fourteen (14) days from the date of receipt of your INZ Skilled Immigrant Authorization Letter; this INZ Skilled Immigrant Authorization Letter will be withdrawn if you fail to register with the Ministry of Business, Innovation and Employment within this stipulated time. On securing your Skilled Migrant Certification, issue the scan copies of the below documents to your Employer's to enable we process your Work Visa i.e. Residence and Work Permit / Visa / Family Resident Permit:

- Data page of valid passport
- Colour Passport Photograph
- Passport photograph and data page of valid passport of family members relocating with you.
- Skilled Migrant Certificate and Card
- Signed Contract of Employment
- Comprehensive Medical report for self and family members (if applicable)
- Scan copy of your Academic and Professional Credentials

[OPTION 4: NOTIFY THE IMMIGRATION SPECIALIST OF THE DURATION OF APPLICATION]

You must now notify the NZ Immigrations / Employment Consultants (Fonua Law Limited) assisting you register with the Ministry of Business, Innovation and Employment that you have nothing but two weeks from the day of receipt of this INZ Skilled Immigrant Authorization Letter to secure your Skilled Migrant Certificate and Card else we shall withdraw this INZ Skilled Immigrant Authorization Letter with immediate effect and your Job Offer will be terminated.

[OPTION 5: PROCEDURES FOR ISSUING WORK VISA]

- Your Employer's are mandated by Law not to commence your Work Visa i.e. Residence and Work Permit / Visa / Family Resident Permit process until you have successfully completed the Skilled Migrant Certification; the major requirement of your Work Visa i.e. Residence and Work Permit / Visa / Family Resident Permit is the Skilled Migrant Certification duly completed by the incoming Employee. You will only be eligible to receive your Work Visa i.e. Residence and Work Permit / Visa / Family Resident Permit from your Employer's only if you complete up the mandatory Skilled Migrant Certification.
- Once we receive all the needed requirements through your Employers (Apex Mega Centre), we shall first issue you with your Entry Clearance Permit / Visa / Family Visa.
- Your Entry Clearance Permit / Visa/ Family Visa will be sent to the New Zealand Embassy in your country of Residence or Country of Origin and we will book you on appointment with them and mandate them to endorse your Passport with your Entry Clearance Permit / Visa / Family Visa.
- Once your international passport is endorsed with the Entry Clearance Permit / Visa / Family Visa, you can immediately relocate to New Zealand and upon your arrival; we will issue you with your Work Permit.

This INZ Skilled Immigrant Authorization Letter is a proof that once we receive the afore mentioned documents which includes your Skilled Migrant Certification from the Ministry of Business, Innovation and Employment, we must as a matter of urgency grant your Work Visa i.e. Residence and Work Permit / Visa / Family Resident Permit. This INZ Skilled Immigrant Authorization Letter is also applicable to other family members of yours you would want to relocate down to the New Zealand with you.
